We are happy to inform that you have been provisionally shortlisted for counseling for admission into the 6-Year Integrated B.Tech Programme of Rajiv Gandhi University of Knowledge Technologies (RGUKT) for the Academic Year 2017-18.

You are **selected for Ongole campus** and requested to attend the certificate verification and admission programme on **07-07-2017** sharp at 08.00 AM at **RGUKT, RK Valley, Idupulapaya Village, Vempalli Mandalam, Kadapa Dist.**

The following are the instructions to the candidates provisionally shortlisted for counseling.

- I. You have to report for counseling on the prescribed date sharp at 08.00 AM at the **RGUKT, RK Valley campus**, at Idupulapaya Village, along with the **original documents /certificates** mentioned below, without fail. It is your responsibility to make all suitable travel arrangements so as to reach the **RGUKT, RK Valley campus, Idupulapaya by 8.00 AM** on the above date.

**Admission shall not be given if you fail to attend the counseling at the said campus in person on the above date and time for whatever reason.** The seat will be allocated to the next best candidate immediately.

- II. **Mere selection for counseling does not guarantee admission.** Admission will be given only if you fulfill all the eligibility criteria. **Your selection stands cancelled in case you fail to produce the original certificates mentioned below at the time of verification or fail to pay the requisite fee.**

III. **Documents to be brought:**

The candidates shall bring the following documents /certificates in **original** along with **three** sets of Xerox copies.

1. Hall Ticket of 10<sup>th</sup> Class Board Examination
2. Grade Sheet of 10<sup>th</sup> Class Board Examination
3. SSC Transfer Certificate (TC) and Conduct Certificate. However in the event of admission already taken elsewhere, the candidate can be given time to produce TC within two days giving an undertaking to that effect and the admission shall be held in reserve till then.
4. Study certificates **(from 4<sup>th</sup> to 10<sup>th</sup> Class)**
5. Candidates selected under Non-local Category have to submit a Residence Certificate as a proof to the effect that the candidate has resided in the state for a total period of 10 years excluding periods of study outside the state or either of whose parents has resided in the state for a total period of 10 years excluding period of employment outside the state.
6. Caste/Community certificate issued by the competent authority **(Meeseva Only)**
7. Income Certificate / Salary Certificate (issued by competent authority).
8. Two photographs each of the candidate and parents(father & mother)
9. Ration Card

10. Aadhar Card of the candidate

11. The candidates who wish to avail bank loan shall bring the following (The loan applications will be available at the bank on the campus):

- a. Additional four sets of copies of the above certificates
- b. Employee Identity Card of parent
- c. Salary Certificate (Latest) of parent
- d. PAN card of Parent
- e. Ration Card / Voter Id Card /Aadhar Card of parent
- f. Six photographs of the candidate and four photographs of the Parent/Guardian

IV. If selected you will have to register for the course and classes will start on 1<sup>st</sup> August, 2017. Late registration is not permitted. The admitted candidates should be prepared to stay for the entire first term from that date.

V. **Fee to be paid:**

If given seat, the tuition fee for the programme for candidates who studied in Schools in AP is Rs.36,000/- (Rupees Thirty Six Thousand only) which is to be paid through the mode of Demand Draft in favor of “**The Director, IIIT RGUKT, Ongole**” payable at **SBI, Idupulapaya Branch** from any nationalized bank. DD shall be paid at the campus allotted on the day of counseling. Students who are eligible for tuition fee reimbursement need not pay the tuition fee (students whose parental annual income is below Rs.1.0 lakh for non SC/ST category and below Rs.2.0 Lakh for SC/ST category and who fulfill the other conditions as per the latest Govt. Rules are eligible for fee reimbursement).

However, every student has to pay a registration fee of Rs.1,000/- (Rs.500 for SC/ST students) and a refundable caution deposit of Rs. 2,000/- at the time of admission, that is a total of Rs.3,000/-
